**Additional information** STYRENE-BUTADIENE COPOLYMERS: Over exposure to styrene monomer may result in styrene sickness. Styrene monomer is classified as possibly carcinogenic to humans (IARC Group 2B) and 1,3-Butadiene as probably carcinogenic to humans (IARC Group 2A). However when both chemicals are bound together in a polymeric form the copolymers are not classifiable as to their carcinogenicity in humans (IARC Group 3).
